AND

Mrs. Naveeda Banu aged about 40 years, D/o. late Usman Khan, residing at No.37/38, 'Rama Residency', Hospital Road, Shivaji Nagar, Bangalore-560 001, hereinafter called the **TRUSTEE** of the OTHER PART.

WHEREAS, late Usman Khan (who died on 18th May 2002), the husband of the Authoress, was desirous of creating an endowment by setting apart and establishing

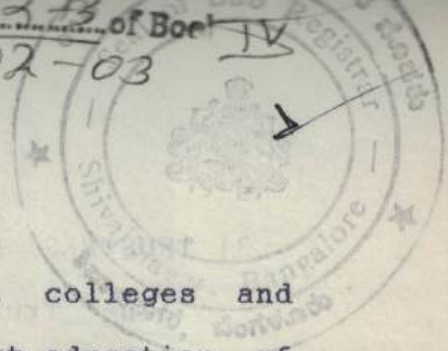

a fund for the establishment of schools, colleges and other educational institutions to impart education of high standards to the under-privileged students of India in general and Karnataka in particular irrespective of caste, creed, religion, nationality, language etc. However, during his life-time, he could not achieve his objectives. Therefore, in order to fulfil the last wishes of late Usman Khan, the Authoress has decided establish a Trust in the memory of her late husband. And in order to give them continuity, the Authoress has thought it fit and proper to establish a Trust to manage the affairs of the institutions that may be founded to achieve the objectives of the Authoress.

Now, therefore, the Authoress and the Trustee have resolved to execute this Trust Deed.

AND in token of her intent, the Authoress has this day made a contribution of a sum of Rs. 5,001/- in cash in the presence of the Trustee with a direction to treat the said amount as the Corpus of the Trust.

AND THEREFORE THIS INDENTURE WITNESSETH AS FOLLOWS:-

1) NAME OF TRUST

The Name of the Trust shall be **"USMAN KHAN MEMORIAL EDUCATIONAL TRUST".**

3) TRUSTEES' PLEDGE

The Trustees do hereby agree that they shall hold and stand possessed of the aforesaid trust property and the funds upon trust for the objects setout herein subject to the provisions and conditions hereinafter contained in these presents.

4) MAIN OBJECTS:-

With the object of imparting education, by establishing schools, college, and other educational institutions like literary, scientific & technical particularly in Karnataka and India without any distinction of religion, race, caste or language.

5) OTHER OBJECTS:

The objects of the Trust are:-

a) Establishment of educational institutions, hostels, training institutes, orphanages, residential schools etc.

b) Awarding scholarships and other financial assistance to students, establishment of community centres, choultries, kalyan mantap etc.

c) Providing medical relief to poor.

d) Grant of adhoc or annual financial assistance to educational institution, institution of scholarship, prizes, medals, rewards and endowments for excellence in studies and scientific research, grant of tuition fee, books, stationery and food, free of cost or at concessional rates, to poor and/or deserving boys and

girls to pursue education in India and/or abroad.

e) Establishment, maintenance and conduct of hospitals, clinics and dispensaries offering medical treatment and cure to the sick and the wounded free of cost or at concessional rates and establishment of ayurvedic, homoeopathic centres.

f) Grant adhoc or annual financial assistance to poor and to grant financial assistance to educated persons from amongst the poor to establish self-employment schemes and establishment of healing centres meditation retreats.

g) Grant dresses, clothes and sarees to the poor.

h) Grant financial assistance and other assistance in kind to the poor and needy.

i) Establishments and running of schools and rehabilitation centres for the mentally retarded and handicapped.

j) The benefits of the Trust shall be open to all Indian Nationals and others, globally serving cause of humanity.

6) PROPERTIES OF THE TRUST:

The properties of the Trust shall be:-

i) the sum of Rs.5,001/- (Rupees five thousand one only) above referred,

ii) any properties movables and/or immovable that may be acquired by purchase or otherwise or all manner of rights, title or interest in properties movable or

immovable that may be acquired by purchase or otherwise,

iii) all additions and accretions to the Trust properties and

iv) all voluntary donations, gifts, legacies or grants in cash or kind accepted by the President upon trust for the objectives set out hereinabove and subject to the provisions and conditions hereinafter contained in these presents.

7) INVESTMENTS BY THE TRUST

The funds of the Trust shall be invested in the modes specified under the provisions of S.13(1)(d) read with S.11(5) of the Income Tax Act 1961 and as amended from time to time.

8) APPLICATION OF FUNDS OF THE TRUST

The funds and the income of the Trust shall be solely utilised for the achievements of its Objects only and no portion of it shall be utilised for payment to the Trustees by way of profit, interest, dividends etc.,

9) TRUSTEES' TERM AND POWER TO CO-OPT

Mrs.NAVEEDA BANU shall be the President and the Authoress shall be the Members of the Trust during their life time unless resigned or removed. If need arises, the President can appoint additional Trustees as per her desire and her decision shall be binding on the other Trustees. Every Trustee appointed by the President shall have the same powers and rights as if he or she has been originally appointed as a Trustee.

monies due or payable to the Trust and grant necessary receipts and discharges thereof.

viii) To receive voluntary contribution from any person or persons whosoever by donation, legacy and gifts and to hold the same upon trust for the objects and subject to the powers, provisions and stipulations setout herein.

ix) To compromise, settle or compound all or any debts, claims, outstandings, accounts, disputes, demands, actions, suits and proceedings whatsoever and refer the same to arbitration.

x) To appoint, suspend or otherwise deal with the staff employed for the administration of the Trust or in carrying out the objects of the Trust and to terminate the services of the staff.

xi) To have all powers ancillary and incidental to effectively carry out the objects of the Trust.

xii) To grant subscriptions and donations in any form to such public charitable institutions whose objects and purpose are similar to these presents.

xiii) If the President is satisfied that any difference of opinion amongst the Trustees is harmful to the cause of the Trust, she shall have the power to remove the Trustee without assigning any reason whatsoever.

xiv) If the President feels that he should handover the responsibility to some other person, she can do so

by informing the Trustees and the person to whom the responsibility will be handed over.

11) POWER AND FUNCTION OF THE SECRETARY

i) Mrs. Shajada Bi shall be the Secretary of the Trust. The Secretary shall assist the President in day to day administration of the Trust.

ii) The Secretary shall act on behalf of the Trust and sign various correspondence with State, Central Government local bodies and all other organisations for any improvement or betterment of the Trust activities.

iii) The Secretary shall exercise all the other powers delegated to him by the President for a specific purpose and for a prescribed period of time.

iv) The Secretary may be paid a monthly honorarium fixed by the Trustees which amount may be enhanced from time to time.

v) In case the Secretary expresses her willingness to retire or her performance is not found to the satisfaction of the Trustees, she may be replaced by the President.

12) PROCEEDINGS OF THE TRUST

The Trust may meet as often as may be necessary for the efficient conduct of the Trust. The members may take decision on any question either in the meeting or by circulation of papers. All the decisions of the Trustees shall be by majority vote. But, if any dispute arises, then the decision taken by the President is

final and binding on all Trustees. The President shall be the Chairman of all the meetings.

13) MINUTES, ACCOUNTS & AUDIT

All accounts of the Trust shall be maintained regularly. They shall be closed on the 31st March of each year. The accounts shall be duly audited by a Chartered Accountant annually.

The President may appoint an Advisory Board which shall advise the Trust for the betterment of the Trust. This should be headed by a Chairman. The appointment of the Chairman and other members of Advisory Committee shall be by the President. These members may be reappointed.

14) NO BREACH OF TRUST BY TRUSTEES

No Trustee shall commit any act of breach of Trust of the Trust fund or property or cause any loss to or commit any fraud in the administration of the Trust fund or property.

15) INDEMNITY

A Trustee shall be indemnified for any act done by him in good faith in the course of the administration of the Trust fund property.

16) NO REMUNERATION TO TRUSTEES

No Trustee shall claim remuneration for services rendered to the Trust but may reimburse himself for expenses incurred by him in the administration of the Trust.

17) TRUSTEES' RETIREMENT

Any one of the Trustees, including the President may retire from the Trust hereof on giving two calendar months' notice in writing of his/her intention to each of the other Trustees for the time being and upon the termination of such two months, the Trustee giving the notice shall automatically cease to be a Trustee. Any notice sent by him to the last known address/es in India shall be sufficient notice hereunder.

18) REMOVAL OF TRUSTEES

The President shall have the power to remove a Trustee suffering from physical or mental disability or accused of misuses the trust's funds or property or misconduct or conduct unworthy of a Trustee, after such enquiry as he considers fit and after giving reasonable opportunity to the said Trustee.

19) APPLICABILITY OF INDIAN TRUST ACT

The provisions of the Indian Trust Act, 1882, shall apply to all matters, not specifically mentioned in these presents. It is however expressly declared that section 20 thereof shall not apply to the Trust.

20) IRREVOCABLE

The Trust is declared as irrevocable.

21) AMENDMENT TO TRUST DEED

No amendments to the Trust Deed and the bye-laws, rules and regulations shall be made which may prove to be repugnant to the provisions of S.2(15), 11, 12 and 13

22) DISSOLUTION OF THE TRUST

In the event of dissolution or winding up of the Trust, the assets remaining on the date of dissolution shall under no circumstances be distributed among the Trustees or Members of the Managing Committee or Governing body but the same shall be transferred to another trust or society or association or institution whose objects are similar to these of this Trust.

- y) The meeting of the board of trustees shall be held at least once in a month but any number of other meetings may be held as and when considered necessary. The Annual General meeting of the trust shall be held once in a year, to consider the annual accounts of the trust.
- z) A minute book shall be kept by the trust. Minutes of the entry into office of every new trustees and of all proceedings of the meetings of the board of trustees shall be recorded in the minute book and shall be signed by the chairperson of the meeting either at the conclusion thereof or at the next meeting.
- aa) Proper and regular books of accounts of all accounts of all receipts and expenditure of the trust shall be maintained by the trustees either in Kannada language or in English.
- ab) On the 31st day of March every year a financial account shall be prepared disclosing all the assets and liabilities of the trust and an income and expenditure account for the whole year and a balance sheet as on 31st March shall be prepared and shall be audited by a **Chartered Accountant** appointed by the trustees for the purpose and the same shall be placed in the general meeting along with the auditor's report and trustees report thereon.
- ac) In case of death, inability, resignation or refusal on the part of any trustees to act as such trustee/s the remaining trustees shall be entitled to nominate any other person/s as they may think fit and proper to act as trustees in place of the trustees so deceased, refusing to act or being unable to act. Provided that the trustees so appointed shall have the same powers and rights as if she/he was originally appointed trustees under these presents.
- ad) No amendment to the trust deed, rules and regulations, shall be made which may prove to be repugnant to the provisions of Section 2(15), 11, 12, 13 and 80G of the Income-tax Act, 1961 as may be amended from time to time. FURTHER NO AMENDMENT SHALL BE
